CERTIFICATE OR URGENCY

- I, the undersigned, **SHAUGHAN HARTLEY COLE**, an admitted Advocate of the above Honourable Court do hereby certify that I am of the respectful opinion that this matter should be heard as a matter of urgency.
- I have been provided with the founding affidavit of the Vice Chancellor of the Applicant, Professor Buhlungu, which is a draft affidavit that was awaiting modest factual information to come to hand before signature by the deponent.
- I have been provided with signed statements from the Security Manager of the East London Campus and the Security Co-Ordinator of the Alice Campus, the content of which has been incorporated into the affidavit of the Vice Chancellor, to confirm the correctness of the factual allegations made.

- 3. At the time of drafting this Certificate of Urgency no Notice of Motion had been prepared, but the content of the intended Notice of Motion is evident from the content of the draft statements made available to me.
- 4. In this matter the Applicant University requires an urgent interdict to restrain identified Respondents, and many other students who have made common cause with them from unlawfully disrupting and disturbing the registration process of students registering at the University.
- 5. The disruption and disturbance has taken the form of interfering with students at the registration venue, and encouraging and calling upon others and inciting others to act in a similar way. The disruption of registration has its origins in demands made by the Student Representative Council members that all students must be allowed to register and secondly that all students must have access to their academic results and obtain their graduation certificates. Although the University is quite content to enter into mature debate on the issues, the Respondents have taken it upon themselves to disrupt

the affairs on the Campus, which disruption has now reached a level where property and safety of persons is severely threatened.

6. The founding affidavit discloses that the Respondents have entered into examination halls where supplementary examinations were being conducted, and have caused the supplementary examinations to be cancelled. On other occasions students have been intimidated with threats that they would be beaten if they did not leave the examination venues. Violence has broken out with staff and students being pursued and chairs being thrown. As a result examinations have been suspended and registration has been totally disrupted. These events are taking place both in Alice and on the East London Campus of the Applicant. Certain of the Respondents have been gathering with sticks and stones and have been intimidating more students to engage in this activity, suggesting they were "sell outs" if they did not. Two students have been injured and one security guard has been injured. The Vice Chancellor has authorised staff to leave the Campus on account of their personal safety risk, and motor vehicles have been moved to more secure venues. Many photographs of stones being thrown and collected on the Campus are available, together with photographs of burning

tyres, and tyres secured by Security Police before they could be set alight.

- 7. The University Management has attempted to engage on a sensible level with the Respondents but to no avail. It is evident that the unlawful activities commenced approximately ten days ago and have continued to escalate despite the efforts of the University to stem the tide. The application was prepared as speedily as possible after it was realised that there was no way of putting an end to the unlawful activities without invoking the assistance of this Court.
- In the light of the urgency of the matter it is not been possible to effect service by the Sheriff of this application on any of the Respondents and it will only be possible to serve the papers together with a copy of the Order.
- The Applicant seeks no more than to prevent illegal activity on the part of the Respondents and there can be no prejudice to the Respondents whatsoever if they are prevented from their actions of intimidation, stone throwing, violence and potential arson.

- 10. The requirements of an urgent interdict in the form of a clear right, the absence of an alternative remedy and actual harm committed and reasonable apprehension of further harm, together with a balance of convenience in favour of the Applicant, have clearly been established.
- 11. In the circumstances the Honourable Duty Judge is requested to allocate a time for the hearing of this matter at the very earliest opportunity.

BE PLEASED TO TAKE NOTICE that application will be made on Friday the 31st of January 2020 at a time to be allocated by the Honourable Duty Judge, as a matter of urgency, for an Order in the following terms:

- 1. That the rules relating to forms and service be dispensed with and that this application be heard as one of urgency in terms of the provisions of Rule 6 (12) of the Rules of Court.
- 2. That a rule nisi do hereby issue calling upon the Respondents to show cause, if any on Thursday the 27th of February 2020 at 09h30 or so soon thereafter as the matter may be heard why:
 - 2.1 the Respondents, and any person acting under their direction and with a common purpose, should not be interdicted and

restrained from unlawfully disrupting and disturbing the registration of students at the East London and Fort Hare Campuses of the Applicant;

- the Respondents, or any persons acting on their instructions and making common purpose with them, should not be interdicted and restrained from interfering with or obstructing the normal business of the Applicant at its East London and Alice Campuses, or conspiring with, encouraging or calling for or inciting any person to act as aforesaid;
- 2.3 the Respondents, or any persons acting on their instructions and making common purpose with them, should not be interdicted and restrained from intimidating fellow students or from disrupting examinations;
- 2.4 the Respondents, or any persons acting on their instructions and making common purpose with them, should not be interdicted and restrained from in any way assaulting any person at the Applicant's East London Campus or the Applicant's Alice Campus, or threatening to assault any such

person, or abusing such persons (students or staff) in any way whatsoever;

- 2.5 that the Respondents, or any one under their instruction or making common purpose with them should not be interdicted and restrained from throwing stones or carrying weapons of any nature on the Campus of the Applicant in East London and in Alice;
- 2.6 Why the Respondents, or any one under their instruction or making common purpose with them should not be interdicted and restrained from gathering within 100 metres of any building of the Applicant on the Campus of the Applicant in East London or Alice, save for the purpose of peacefully attending to the legitimate objectives of the University program;
- 2.7 the Respondents, jointly and severally the one paying the other to be absolved should not be ordered to pay the costs of this application.

- 3. That the Orders in paragraphs 2.1 to 2.6 *supra* operate as interim interdicts with immediate effect pending the finalisation of this application on the return day, or the extended return day.
- 4. That service of this Order be effected
 - 4.1 by personal service on the Respondents;
 - 4.2 affixing a copy of this application and Order on the noticeboard of the Student Representative Council office.
- That the members of the South African Police Services are authorised to take such action as may lawfully be permitted to be taken in the event of any of the Respondents refusing to comply with this Order, save that this Order shall not preclude or limit members of the South African Police Services from exercising any power which he or she may have in terms of any law.

BE PLEASED TO TAKE FURTHER NOTICE that the affidavit of the Vice Chancellor and Principal of the Applicant, Professor Sakhela Buhlungu, together with annexures thereto will be used in support of this application.

KINDLY set the matter down for urgent hearing accordingly.

STATEMENT BY YANGA MAKABANE

Re-events surrounding the students protest activities from 20 to 31 January 2020

- 1 Yanga Makabane, Acting Security Manager at Fort Hare East London state that:
 - On Saturday 18 January 2020, I received a call from my Director, Mr Mbude about the possible disruption of the registration by students and he instructed me to draw a security plan and re-enforce security to make sure that disruption does not occur.
 - 2. I organized my in-house security personnel and re-enforced by sourcing riot control Security Company to curb the disruption.
 - 3. On Monday 20 January 2020, the registration started but was stopped for about 4 hrs after the SRC students demanded that it be stopped because they have an urgent mass meeting.
 - 4. Myself, Dr Masha, Registrar, Mr Mbude & Dean of students & Mihla Hanise (SRC Premier) meet next to itec and urged Mr Hanise to allow the registration to continue considering that parents came to register their children. His response was he cannot unilaterally decide so he needs to consult other SRC members.
 - 5. The students meet infront of Main building therafter, the Dean of Students clarified the misinformation that people are not allowed to register and told everybody to register and the registration went well the whole day.
 - 6. On Thursday 23 January 2020, There was a supplementary exam at Old Library building where a group of students disrupted the exam and after consultation with Dr Masha and accounting lecturers, the exam was cancelled because the protesters were making a lot of noise therefore rendering the environment not conducive for exam.
- 7. On Friday 24 January 2020, at around 9am a group of protesters mostly wearing EFFSC and PASMA came to try and disturb the registration and

those who came for registration refused to go outside but some staff members were intimidated and left registration venue (ELCO).

- 8. On Saturday 25 January 2020, the registration went smoothly.
- 9. On Monday 27 January 2020, SRC President, Mr Hanise and other SRC members disrupted the registration demanding students to go out and staff members to not to work. The mass meeting continued and was addressed by SRC President and the President of SAUSA, Mr Mugabe and the meeting resolved for a strike.
- 10. From Tuesday 28 January to 30 January, the group of protesters has been disrupting university operations and came several times throwing stone at security personnel and the buildings but the security and SAPS (Pops) managed to disperse the group. From 28 January 2020, the tyres were burnt around UFH buildings and stones were thrown.
- 11. People who were amongst the leaders of protesters are:
 - 1. Madasa
 - 2. Mampintsha(not sure of his real name or surname)
 - 3. Protesters mostly wearing EFFSC & PASMA regalia

STATEMENT BY DR ROSE KANYI MASHA

- I, Or Rose Kanyi Masha, Deputy Registrar: Academic Administration, University of Fort Hare, state under oath that:
 - as per the schedule prepared and implemented by the division of which I am head, registration of students for the 2020 academic year began on 20 January 2020.
 - 2. I confirm that the registration process was disrupted and continues to be disrupted by protestors, some of which are identifiable SRC members, ordinary students, and others who are unknown to me.
 - 3. below is a record of what I observed:

STATEMENT BY MIFUNDO PALISO

Re: Events surrounding registration disruption by Src jed prospective returning students

- I, Mfundo Paliso Acting Security Coordinator (Alice Campus), state that:
- On Tuesday 28 January 2020, I was tasked with ensuring that the ragistration process in the Alice Campus goes on without any disruptions.
- I encountered a group of about 100 prospective returning students singing in front of one of the registration venues (Sports Complex), this group was led by the Student Representative Council members.
- I confirm that I saw James Ngabeni, Lihle Ndabambi, Mbenya, Mdekazi and Lwandile Mgedezi other Src members leading a group of students on Tuesday, 28/01/2020 intimidating and turning away those who wanted to register.
- 4. They left the Sports Complex and moved towards the Great Hall where they again threatened those who wanted to register. From there they moved to the Main Gate blocking the gate and locking it after they had vandalized our padlocks,
- 5. On the 29/01/2020 all necessary precautions were put in order for the registration to commence but again Src led group went from venue to venue where they would intimidate and threaten any person who was waiting to register. From there they started to throw stones at the private security personnel hired to ensure smooth running of the registration. I can confirm that James Ngabeni, Mbenya, Mdekazi, Lihle Ndabambi and other members whose names I do not know.
- 6. On the 30/01/2020, widespread intimidation of those who wished to register took place in front of the Great Hall with James Ngabeni, Lihie Ndabambi at the forefront. There was also a woman whose name I do not know but have her photo. On the orders of James Ngabeni and Lihie Ndabambi, students moved from in front of the Great Hall and went towards the men's residences where they blocked every person coming to register, being insulted and pelted with stones. The disruptive group then started to engage the private security company and threw stones at the Great hall breaking windows and tampering with the electricity supply of the venue.
